Please read this page before completing the form.

The United States Citizenship and Immigration Service (USCIS) requires proof of your ability to pay educational and living expenses here in the United States. To do this, you must show certified documents that total an amount greater than or equal to the total costs shown on this form. Without such documentation, a Certificate of Eligibility for Nonimmigrant Student Status (I-20) will not be issued.

Once the applicant's file is complete, the student has been admitted, and a deposit is received in the Admission Office, upon request, USP will issue an I-20. Please retain a copy of certified documents. United States Consuls closely scrutinize the statements of financial resources given by non-immigrant visa applicants. This Certification of Finances will help such officials make their decisions and expedite visa issuance.
